

## Independent Review Entities Certified to Perform External Review in Kentucky

Updated **6/17/2026**

In accordance with KRS 304.17A-623, insurers doing business in Kentucky are required to establish and maintain an external review process to be used by the insurer or its designee to address disagreements between the covered person and the covered person's insurer regarding an adverse determination. In some cases, a coverage denial, made by the insurer, its designee, or a private review agent.

In accordance with 806 KAR 17:290, an insurer must request the external review from a Department of Insurance (DOI) assigned, certified independent review entity (IRE) via eServices for purposes of conducting the external review. Following is a listing of the IREs certified to perform external reviews in this state.

The process for assigning an Independent Review Entity (IRE) through the **eServices** will be the following:

1. Insurers and private review agents (PRAs) shall determine if an external review is available to the covered person pursuant to KRS 304.17A-623(3) and shall notify the Department through eServices of a request for an assignment.
2. The Department's eServices shall assign to the insurer or PRA an IRE for each case based upon a rotational system.
3. An insurer or PRA shall verify that no conflict of interest pursuant to KRS 304.17A-627(8) exists with the assignment given by the Department.
4. If a conflict does exist, the insurer or PRA shall contact the Department through eServices for an additional assignment.
5. To obtain an eServices account, contact [DOI.ISHelpDesk@ky.gov](mailto:DOI.ISHelpDesk@ky.gov) and copy [DOI.UtilizationReview@ky.gov](mailto:DOI.UtilizationReview@ky.gov).

The process for assigning an Independent Review Entity (IRE) through a **manual process** if the eServices system is unavailable (i.e. system is down, password needs to be reset, etc.)

1. Attempt to contact the Department via email to [DOI.ISHelpDesk@ky.gov](mailto:DOI.ISHelpDesk@ky.gov) and copy [DOI.UtilizationReview@ky.gov](mailto:DOI.UtilizationReview@ky.gov). If unsuccessful in reaching someone, proceed to step 2.
2. Access the Kentucky Department of Insurance's website and locate the listing of the approved Independent External Review entities via [DEPARTMENT OF INSURANCE \(ky.gov\)](http://DEPARTMENT OF INSURANCE (ky.gov)).
3. Select an IRE and contact them to see if they can accept the case. If so, send them the case as normal. If not, continue selecting IREs until one can accept the case.
4. After the IRE has agreed to accept the case complete the appropriate paperwork for the IRE and transmit the case to the IRE and complete the HIPMC-IRE-2 Assignment form and forward to Department indicating the case was assigned Outside of the eServices system and provide an explanation and documentation of the reason for the manual assignment.

Upon assignment of an external review to an IRE, an insurer/private review agent is required to complete an Assignment of Independent Review Entity Form and return it to the DOI within one (1) business day of IRE assignment. **The IRE are required to notify the Insurer/Private Review Agent/Department of the acceptance of an assignment. The notification to the Department must be submitted via the [DOI.UtilizationReview@ky.gov](mailto:DOI.UtilizationReview@ky.gov) email within one business day.** If you have any questions relating to the DOI's Independent External Review Program, you may contact the Utilization Review Branch at [DOI.UtilizationReview@ky.gov](mailto:DOI.UtilizationReview@ky.gov) or (502) 564-6088.
