Convictions Activity

<u>Rotricia Kirby</u> – Charged with one (1) count of Theft by Deception Over \$10,000 and one (1) count of Criminal Possession of a Forged Instrument, 2^{nd} Degree. Kirby pled guilty to Theft by Deception Over \$500 and Criminal Possession of a Forged Instrument, 2^{nd} Degree, and was sentenced to three (3) years in prison for both counts. Additionally, restitution of \$18,566.47 was ordered to be paid to the insurer, Constitution Life Insurance Company, at a rate of \$100 per month through the Trigg County Circuit Court Clerk's Office.

<u>Jessica Brotzge</u> – Convicted of three (3) felony counts, one (1) count was Dismissed Without Prejudice, and sentenced to one (1) year on each count, to run concurrent for a total of one (1) year with no motion for probation.

<u>Robert Marshall</u> – Convicted of two (2) felony counts, one (1) count was Dismissed Without Prejudice, and sentenced to five (5) years on each count, to run concurrent; Pretrial Diversion for three (3) years.

<u>Ronisha Squire</u> – Convicted of three (3) felony counts, one (1) count was Dismissed Without Prejudice, and sentenced to one (1) year on each count, to run concurrent; Pretrial Diversion for one (1) year; and pay \$826 in restitution.

<u>**Dekota Wales**</u> – Convicted of three (3) misdemeanor counts, one (1) count was Dismissed With Prejudice, and sentenced to ninety (90) days each count, conditionally discharged for two (2) years, or when restitution of \$726 is paid in full.

Edward Wales – Convicted of three (3) felony counts, one (1) count was Dismissed Without Prejudice, and sentenced to five (5) years on each count, to run concurrent; Pretrial Diversion for three (3) years to run concurrent; and pay \$2,786.99 in restitution.

<u>Kenneth Tilley</u> – Convicted of three (3) felony counts, one (1) count was Dismissed Without Prejudice, and sentenced to one (1) year on each count, to run concurrent; probated for one (1) year.

<u>Shanice Hughes</u> – Convicted of three (3) felony counts, one (1) count was Dismissed With Prejudice, and sentenced to one (1) year on each count, to run concurrent; diverted for one (1) year, or until restitution in the amount of \$26 is paid in full.

<u>William Wales</u> – Convicted of three (3) misdemeanor counts, one (1) count was Dismissed With Prejudice, and sentenced to 365 days on each count, to run concurrent; Conditional Discharge for two (2) years.
