Benefit Chart of Medicare Supplement Plans Sold on or after January 1, 2020**

This chart below shows the benefits included in each of the standard Medicare supplement plans. Some plans may not be available. Every company must make Plan "A" and either Plan D or Plan G available. Only applicants' first eligible for Medicare before 2020 may purchase Plans C, F, and high deductible F.

Basic Benefits:

- **Hospitalization** -Part A coinsurance plus coverage for 365 additional days after Medicare benefits end.
- **Medical Expenses** -Part B coinsurance (generally 20% of Medicare-approved expenses) or co-payments for hospital outpatient services. Plans K, L and N require insureds to pay a portion of Part B coinsurance or co- payments.
- **Blood** -First three pints of blood each year.
- **Hospice**— Part A coinsurance

- Plans F and G also have a high deductible option; requiring insured to first pay a plan deductible of [\$2240] before the plan begins to pay. Once the plan deductible is met, the plan pays 100% of covered services for the rest of the calendar year. High deductible plan G does not cover the Medicare Part B deductible. However, high deductible plans F and G count your payment of the Medicare Part B deductible toward meeting the plan deductible.
- Plans K and L pay 100% of covered services for the rest of the calendar year once you meet the out-of-pocket yearly limit.
- Plan N pays 100% of the Part B coinsurance, except for a co-payment of up to \$20 for some office visits and up to a \$50 copayment for emergency room visits that do not result in an inpatient admission.
